s. 24. (6) The licensee shall ensure that the care set out in the care plan is provided to the resident as specified in the plan. O. Reg. 79/10, s. 24 (6).

Findings/Faits saillants :

On observation, one resident presented with health concerns. Review of the resident health care record & interview with one RPN confirmed the physician ordered treatment for the health concern, has not been provided to the resident since ordered.
