WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s.

15. Accommodation services

Specifically failed to comply with the following:

- s. 15. (2) Every licensee of a long-term care home shall ensure that,**
**(a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8,
s. 15 (2).**
**(b) each resident's linen and personal clothing is collected, sorted, cleaned and
delivered; and 2007, c. 8, s. 15 (2).**
**(c) the home, furnishings and equipment are maintained in a safe condition and
in a good state of repair. 2007, c. 8, s. 15 (2).**

Findings/Faits saillants :

1. The licensee has not ensured that the home, furnishings and equipment are kept clean and sanitary.

The washrooms in two resident rooms have a sheet of laminate from the ceiling to the floor between the toilet and window to the outside. The windows and space between the laminate and windows in each room is heavily soiled. Four staff confirmed these areas are not cleaned as it is difficult to reach into them. [s. 15. (2) (a)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure the home furnishings and equipment are kept
clean and sanitary, to be implemented voluntarily.***
