The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with LTCHA, 2007, S.O. 2007, c.8, s. 19 (1):

Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff.

Findings:

On 05 April 2011, the inspector confirmed the following information:

An incident of verbal abuse occurred involving a resident and an employee of the home. The resident had been incontinent of bowel and the employee made comments which were indignant and disrespectful. Signed statements from other staff indicated they overheard this employee being verbally abusive towards the resident. This employee attended in-services on Gentle Persuasive Approaches and abuse training and had signed the Staff Annual Re-Affirmation Statement on abuse/neglect.
