The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 29, 2016

Critical Incident #2587-000006-16 related to an electrical fire and smoke in the home and subsequent evacuation of building occupants on July 28, 2016.

During the course of the inspection, the inspector(s) spoke with the Senior Manager of Nursing Operations (Con Med), Environmental Services Supervisor (Con Med), Administrator and Food Services Supervisor.

During the course of the inspection, the inspector toured the home which included the basement, kitchen, dining room, service corridor and main foyer. A remediation company was observed to be on site and in the process of cleaning the affected areas of the home (kitchen, basement, service corridor, dining room) and an air quality test was pending. The inspector also toured neighbouring Maple Park Lodge, the receiving home for the majority of evacuated residents. The corporate emergency evacuation plan was reviewed and staffing, supplies, equipment, safety and security systems, eating and sleeping accommodations at Maple Park Lodge were observed and confirmed to be in place.

Residents were permitted to return to their home beginning the afternoon of July 29, 2016 and all services were back to normal as of August 2, 2016.
