A critical incident was submitted in November 2017, related to a natural gas leak that occurred in November 2017. A complaint was also received regarding the same issue in November 2017. Please see complaint inspection report #2018-539120-006 for details and related non-compliance.

During the course of the inspection, the inspector(s) spoke with the Administrator, corporate Environmental Services Manager, maintenance person, personal support workers, residents, a family member, housekeepers, registered staff, fire inspectors, maintenance contractor and a gas company representative.

During the course of the inspection, the inspector toured the home, checked the operation of exhaust and supply air systems in resident occupied areas, reviewed emergency plans, maintenance policies and procedures and maintenance service reports.
