Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning**

**Specifically failed to comply with the following subsections:**

**s. 71. (5) The licensee shall ensure that an individualized menu is developed for each resident whose needs cannot be met through the home's menu cycle. O. Reg. 79/10, s. 71 (5).**

**Findings/Faits sayants :**

1. The home does not have an individualized menu developed for an identified resident to meet their dietary needs. The food service supervisor and the homes dietitian confirmed that an individualized menu was not implemented for the resident despite dietary preferences.

The homes regular menu indicated a menu item that the resident does not consume however, there was no individualized menu in place and there was no alternative offered to the resident for the lunch meal.

The resident did not consume a full lunch meal and their weight has declined 6.8kg over the past three months.
