During the course of the inspection, the inspector(s) spoke with a resident, a Personal Support worker (PSW), the Director of Care and the Administrator.

During the course of this inspection, the inspector conducted a walking tour of the North and Georgian wings and made observations related to the use of side rails, reviewed resident health care records including the plans of care and side rail assessments/consents, reviewed the home's revised "Side rail Assessment", #NPPM: 4.14c revised in November 2016, the home's "Bed Safety" policy, #NPPM: 4.14 revised in December 2016 and reviewed a memo circulated to all residents and family members related to the home's review of safety measures related to beds and side rails.
