WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

- s. 6. (8) The licensee shall ensure that the staff and others who provide direct care to a resident are kept aware of the contents of the resident's plan of care and have convenient and immediate access to it. 2007, c. 8, s. 6 (8).
- s. 6. (11) When a resident is reassessed and the plan of care reviewed and revised,
- (a) subsections (4) and (5) apply, with necessary modifications, with respect to the reassessment and revision; and
- (b) if the plan of care is being revised because care set out in the plan has not been effective, the licensee shall ensure that different approaches are considered in the revision of the plan of care. 2007, c. 8, s. 6 (11).

Findings/Faits saillants:

- 1. Different approaches were not considered in the revision of an identified resident's Activities Participation plan of care. The identified resident suffers from dementia, is at high risk for pressure ulcers, and spends most of his/her time in bed. The resident's quarterly assessments of April 2011, July 2011, October 2011, and January 2012, all indicate that the resident had no involvement in activities. The resident's plan of care for Activities Participation was not revised to include any new strategies to address this issue, and no referrals were made to arrange one-to-one activities for the resident, such as Music Therapy or the Volunteer Visitor program.
- 2. Referrals were initiated for Music Therapy and the Volunteer Visitor program after the inspector arrived in the home on February 28, 2012.

3. When interviewed on February 29, 2012, the Recreation Services Assistant was not aware of the identified resident's plan of care for Comfort, and that the resident had been referred to, and was receiving services from the Complementary Care Program in the home.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that different approaches are considered when revising the Activities Participation plan of care for an identified resident, to be implemented voluntarily.
