**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (2) The licensee shall ensure that the care set out in the plan of care is based on an assessment of the resident and the needs and preferences of that resident. 2007, c. 8, s. 6 (2).

Findings/Faits saillants :

1. The licensee failed to ensure that the dental care section of the plan of care included the resident/family's preferences.

Clinical record review and staff interview revealed that resident #1's family brought their own dental care products and informed a staff of preference for use. The plan of care, however, does not indicate resident/family's mouth care preferences. [s. 6. (2)]

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s.

22. Licensee to forward complaints

Specifically failed to comply with the following:

s. 22. (1) Every licensee of a long-term care home who receives a written complaint concerning the care of a resident or the operation of the long-term care home shall immediately forward it to the Director. 2007, c. 8, s. 22 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that a written complaint that was received concerning the care of a resident was forwarded to the Director.

Clinical record review and staff interview confirmed that the licensee did not forward to the Director an identified complaint received on September 3, 2013 from the resident #1's family. [s. 22. (1)]
