WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 144. No licensee of a long-term care home shall discharge a resident from the long-term care home unless permitted or required to do so by this Regulation. O. Reg. 79/10, s. 144.

1. The licensee discharged Resident #001 and this discharge was not permitted or required by the Regulation.

Resident #001 was discharged from the home on the same day as the resident was admitted and the home was not permitted or required to do so by the Regulation.

- 1. The home had contacted the resident's family and indicated that the home could not care for the resident and the family needed to pick the resident up from the home.
- 2. The home had packed up the resident's belongings for pick up.
- 3. The home had documented the discharge in the Point Click Care notes.
- 4. The Administrator confirmed the care requirements had not changed from the assessments on which the admission was accepted.
- 5. The Administrator and the Assistant Director of Care confirmed there were staff present in the home who could have provided care to the resident and the home had a back-up plan to care for the resident if unable to contact the family.

The Regulation does not permit or require a licensee to discharge a resident in the circumstances described above. [s. 144.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that no licensee of a long-term care home shall discharge a resident from the long-term care home unless permitted or required to do so by this Regulation, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 184. Withdrawal of approval by licensee

Specifically failed to comply with the following:

s. 184. (2) If information provided to the licensee by the placement co-ordinator indicates that there has been a change in the applicant's condition and, as a result, a ground for withholding approval mentioned in subsection 44 (7) of the Act exists, the licensee may withdraw the approval of the applicant's admission to the long-term care home in accordance with paragraphs 1 and 3 of subsection 44 (14) of the Act. O. Reg. 79/10, s. 184 (2).

Findings/Faits saillants:

1. The licensee withdrew its approval of Resident #001's admission to the home in contravention of this provision and s.44(14)of the Act.

Resident #001 applied for long stay placement and was accepted and placed on a wait list for admission, based on assessment information provided by CCAC. The resident then applied for short stay admission, and was accepted based on the assessment information. Prior to the short stay admission, CCAC provided an updated assessment for the resident which was unchanged from the initial assessment on which the admissions were accepted.

The home discharged Resident #001 on the day of admission for short stay placement and then withdrew its acceptance for long stay placement.

The assessment information on which the home approved the application of this resident for long stay placement and for short stay placement, and the information on the updated assessment prior to the short stay admission, did not indicate there had been a change in the applicant. As a result, grounds for withdrawing the applicant's admission to the long term care home did not exist.[s. 184. (2)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the licensee may withdraw the approval of the applicant's admission to the long-term care home only in accordance with this provision and s.44(14)of the Act, to be implemented voluntarily.
