**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 104.
Beds allowed under licence**

Specifically failed to comply with the following:

s. 104. (1) A licensee shall not operate more beds in a long-term care home than are allowed under the licence for the home or under the terms of a temporary licence issued under section 111 or than are authorized under section 113. 2007, c. 8, s. 104. (1).

Findings/Faits saillants :

1. The licensee failed to ensure that they did not operate more beds than were allowed under the licence for the home or under the terms of a temporary licence issued under section 111 or than are authorized under section 113.

It was verified that the current licenced capacity for the home was 39 beds. Interview with the Administrator confirmed the licensee applied for a temporary license on March 12, 2015, to increase their capacity by one additional bed, to 40 beds in total. The Administrator was not able to provide verification that the temporary licence had been received at the time of this inspection. A resident was admitted to the home on an identified date in June 2015. This admission was the fortieth resident in the home, one over their current licenced capacity of 39 beds. [s. 104. (1)]
