**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): May 27, 2013**

**This follow-up inspection was completed off-site and was evaluated for compliance based on required documentation only. A follow-up inspection was conducted on-site on January 10, 2013 to determine compliance with tuberculosis screening requirements for employees and residents and infection prevention and control training for designated staff. At the time of inspection, not all staff were screened for tuberculosis and an Order(#001) was issued on February 19, 2013. As of the date of this inspection report, documentation provided indicates that all staff who are currently working at the home have been screened for tuberculosis.**
