The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): April 10, 11, 12, 15 and 16, 2019

This complaint inspection included four complaint logs: Log 005068-19, 001755-19 and 005288-19 related to staffing patterns in the home and infection control practices; and Log 007674-19 related to disease outbreaks in the home.

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care, Assistant Director of Care, Nurse Practitioner, Activity Programs and Services Director, Personal Support Workers and residents.

The Inspectors reviewed resident care documentation related specifically to bathing, toileting and meal service, documents related to outbreak management and infection control, to the staffing pattern in the home, schedules for nursing staff and staffing evaluation.
