Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct an Other inspection.

This inspection was conducted on the following date(s): August 7 and 8, 2019

Compliance Order #001 and #002, related to LTCHA 2007, s.19 (1) and LTCHA 2007, s.76 (4), were issued May 2, 2019 under Inspection #2019_617148_0010, with a compliance due date of August 2, 2019. Both orders have been closed as the previous licensee, Dundas Manor Limited, is no longer responsible for the management of this long-term care home as of July 22, 2019. The new licensee, Rural Healthcare Innovations Inc., will be responsible to ensure compliance with the Long-Term Care Homes Act, 2007 as per the conditions of their licensee.

This inspection was the ensure compliance with LTCHA 2007, s.19 (1) and LTCHA 2007, s.76 (4).

No non-compliance was identified.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Executive Assistance, Office Manager, Registered Nurses, Registered Practical Nurses, Personal Support Workers, Dietary staff, Laundry staff and Activity staff members.

The Inspector reviewed the compliance plan related to Compliance Orders #001 and #002, the licensee's policy to promote zero tolerance of abuse and neglect of residents, content of abuse and neglect training developed for staff members and records of training provided to staff members related to abuse and neglect. The Inspector also observed staff to resident and resident to resident interactions.
