The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): May 9 - 11, 2016.

This inspection is related to a complaint regarding facility maintenance and resident safety due to a leaking roof.

An inspection regarding two Critical Incident Systems (CIS) reports submitted to the Director related to an incident, in which the residents involved were not properly assessed, resulting in the risk of harm to the residents involved and an incident which caused an injury to a resident was conducted concurrently with this inspection. For findings of non compliance, see inspection #2016_273638_0008.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Director of Support Services (DSS), Registered Nurse (RN), Personal Support Workers (PSW) and Housekeeping Aids.

The inspector(s) also conducted a tour of resident care areas, observed the provision of maintenance services, observed staff to resident interactions, reviewed relevant maintenance records and reviewed numerous licensee policies, procedures and programs.
