The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The licensee has failed to comply with the LTCHA, 2007, S.O. 2007, c.8, s.15(2)(a). Every licensee of a long-term care home shall ensure that,

(a) the home, furnishings and equipment are kept clean and sanitary.

#### Findings:

- 1. Accumulated matter noted under fixed equipment in both serveries, especially under the dishwashers.
- The floor in the main kitchen is visibly soiled, with black residue build-up along the perimeter and in high traffic areas. The floor has not been deep cleaned in several weeks according to dietary staff. Routine mopping has not removed the build-up.
- 3. Exhaust grilles located in resident washrooms in the section devoted to interim beds on the 3rd floor are very thick with dust.
- 4. Three tub lift seats, located in Eramosa, Paisley and Wellington tub rooms, identified to have visible residue on the underside.
- 5. The carpeting is heavily stained in high traffic areas, such as the lounge, near the nursing stations and in sitting areas.

Previously issued as criterion O3.1 under the MOHLTC Homes Program Standards Manual.

### Additional Required Actions:

**VPC** - pursuant to the *LTC Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achielving compliance with s. 15(2)(a) in respect to ensuring that the home, furnishings and equipment are kept clean and sanitary, to be implemented voluntarily.
