Non-compliance with requirements under the Long-Term Care the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8. Nursing and personal support services

Specifically failed to comply with the following subsections:

s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).

Findings/Faits saillants:

1. The licensee did not ensure at least one registered nurse who is both an employee of the licensees and a member of the regular nursing staff is on duty and present in the home at all times, except as provided for in the regulations. The night shift of August 20th, 2012 the home did not have a registered nurse or registered practical nurse who is both an employee of the licensee and a member of the regular nursing staff on duty and present in the home. Two registered practical nurses from an employment agency were on duty and present in the home. The licensee failed to ensure that the LTC home had either DOC or RN who is a member of the home's regular staff on call and a RPN who is an employee of the licensee and a member of the regular nursing staff as required by the O Reg 79/10 s. 45 2. ii [s. 8. (3)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that at least one registered nurse who is both an employee of the licensees and a member of the regular nursing staff is on duty and present in the home at all times, except as provided for in the regulations, to be implemented voluntarily.
