The purpose of this visit was to conduct a follow-up inspection to previously issued non-compliance made under the Ministry of Health and Long Term Care Homes Program Standards Manual related to unmet criteria:

- O3.1 (Housekeeping)
- M3.26 (Infection Prevention and Control)

During the course of the inspection, the inspector spoke with the Administrator, Director of Care and maintenance person. During the course of the inspection, the inspector conducted a walk-through of resident bedrooms, ensuite washrooms, dining rooms and bathing rooms.

The following Inspection Protocols were used during this inspection:

- Accommodation Services Housekeeping
- Infection Prevention and Control
- Safe and Secure Home

Findings of Non-Compliance were found during this inspection. The following action was taken:

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The licensee has failed to comply with the LTCHA 2007, S.O., 2007, s.15(2)(a) & (c). Every licensee of a long-term care home shall ensure that,

- (a) the home, furnishings and equipment are kept clean and sanitary and;
- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair.

Previously issued as criteria O3.1 under the Ministry of Health and Long Term Care Homes Program Standards Manual [related to section 15(2)(a)].

#### Findings:

- Visibly soiled night tables noted in a number of identified resident rooms in 3W and in 3E.
- Walls, bathroom doors and closet doors visibly soiled in a number of identified resident rooms in 3W and
  in 3E.
- Privacy curtains stained in a number of identified resident rooms in 3W and in 3E.
- Heavy accumulation of debris on the floor in the 3E soiled utility room.
- Many resident room walls in 3E were noted to have flaking paint and heavy scuffing.
- The bathroom door trim (bottom 2 feet) in many resident rooms in 3E is exposed and damaged, exposing metal or rust.

#### **Additional Required Actions:**

**VPC** - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the home, furnishings and equipment are kept clean and sanitary and in a good state of repair, to be implemented voluntarily.

WN #2: The licensee has failed to comply with O. Reg. 79/10, s. 91. Every licensee of a long-term care home shall ensure that all hazardous substances at the home are labeled properly and are kept inaccessible to residents at all times.

#### Findings:

A janitor's closet containing disinfectants and cleansers was left unlocked and accessible to residents in the 3E home area.

WN #3: The licensee has failed to comply with O. Reg. 79/10, s. 15(1)(b). Every licensee of a long-term care home shall ensure that where bed rails are used,

(b) steps are taken to prevent resident entrapment, taking into consideration all potential zones of entrapment.

#### Findings:

Beds located in 5 identified resident rooms all have inadequately sized mattresses for the style of the bed frame. One bed has mattress guide brackets whereby the mattress does not fit into the brackets to keep the mattress from sliding and the remaining have mattresses that have gaps of greater than 4.75 inches (as per Health Canada's Guide Document entitled "Adult Hospital Beds: Patient Entrapment, Side Rail Latching Reliability and Other Hazards") between the head board and end of the mattress or the footboard and the end of the mattress.

The home hired a contractor to evaluate the safety of the beds for entrapment zones in 2010, however the inspection did not include zone 7 entrapment hazards (between end of mattress and head board or footboard).

#### **Additional Required Actions:**

**VPC** - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the home takes steps to prevent resident entrapment, taking into consideration all potential zones of entrapment, to be implemented voluntarily.
