

The licensee has failed to ensure that for the 87 resident bedrooms that were not served by air conditioning, the temperatures were measured and documented in writing once a day in the afternoon between 12 p.m. and 5 p.m.

Rationale and Summary

The home measured and documented the temperatures in eight resident bedrooms daily. Three of these resident bedrooms were not served by air conditioning. The home's floor plan that outlined the resident bedrooms with and without air conditioning units installed, identified that there were 87 resident bedrooms not served by air conditioning.

A Maintenance staff reported they selected 10 resident bedrooms randomly for the temperature to be measured daily. These temperatures were not reflected in the home's log for Indoor Air Temperature. The Environmental Services Manager (ESM) reported the temperature of the 87 resident bedrooms not served by air conditioning were not measured and documented daily.

Failure to ensure temperatures were measured and documented daily in all resident bedrooms not serviced by air conditioning had the potential to increase the residents' risk of heat related illness.
