Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Registered and direct care staff members.

During the course of the inspection, the inspector(s) reviewed the following: zero tolerance for abuse and neglect policy, education records for zero tolerance of abuse and neglect and the health record for an identified resident.

The following Inspection Protocols were used during this inspection:

Continence Care and Bowel Management

Dignity, Choice and Privacy

Prevention of Abuse, Neglect and Retaliation

Findings of Non-Compliance were found during this inspection.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect
Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that an identified resident was free from neglect by the staff.

- An identified resident was not provided with care according to the written plan of care.
- Resident identified at risk for further skin breakdown related to skin impairment issues.
- The plan of care documents the residents requirement to be checked for incontinence at least every two hours.
- Upon providing care on an identified date, the resident's bed and clothing were observed to be saturated in urine.
- A peri towel saturated with urine was found inside the incontinent brief and was resting on top of a pressure ulcer.
- An internal investigation was conducted by the home and as a result; the direct care staff member assigned to the resident on the identified date was terminated.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that residents are not neglected by the licensee or staff, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 51. Continence care and bowel management

Specifically failed to comply with the following subsections:

s. 51. (2) Every licensee of a long-term care home shall ensure that,

(a) each resident who is incontinent receives an assessment that includes identification of causal factors, patterns, type of incontinence and potential to restore function with specific interventions, and that where the condition or circumstances of the resident require, an assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for assessment of incontinence;

(b) each resident who is incontinent has an individualized plan, as part of his or her plan of care, to promote and manage bowel and bladder continence based on the assessment and that the plan is implemented;

(c) each resident who is unable to toilet independently some or all of the time receives assistance from staff to manage and maintain continence;

(d) each resident who is incontinent and has been assessed as being potentially continent or continent some of the time receives the assistance and support from staff to become continent or continent some of the time;

(e) continence care products are not used as an alternative to providing assistance to a person to toilet;

(f) there are a range of continence care products available and accessible to residents and staff at all times, and in sufficient quantities for all required changes;

(g) residents who require continence care products have sufficient changes to remain clean, dry and comfortable; and

(h) residents are provided with a range of continence care products that,

(i) are based on their individual assessed needs,

(ii) properly fit the residents,

(iii) promote resident comfort, ease of use, dignity and good skin integrity,

(iv) promote continued independence wherever possible, and

(v) are appropriate for the time of day, and for the individual resident's type of incontinence. O. Reg. 79/10, s. 51 (2).

Findings/Faits saillants :

1. The licensee failed to ensure that an identified resident who requires continence care products received sufficient changes to remain clean dry and comfortable.

-The plan of care for an identified resident documents the requirement to be checked for incontinence at least every two hours.

-The residents clothing and bedding were observed to be saturated in urine.

- Through review of the internal investigation and interviews held with staff members of the home it was determined that the resident was not provided with sufficient changes to remain dry and comfortable.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all residents who require continence care products have sufficient changes to remain clean, dry and comfortable, to be implemented voluntarily.
