The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 24th, 25th and 26th, 2015.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, a Registered Nurse, Registered Practical Nurses, Personal Support Workers (PSW), the Environmental Manager, laundry staff, residents and family members.

During the course of the inspection the inspector completed tours of all Resident Home Areas, toured the laundry department, conducted linen audits and reviewed linen invoices, reviewed staffing patterns inclusive of staffing plans, schedules and annual staffing evaluation records, reviewed complaint policies and procedures, reviewed new employees training and orientation practices and staff qualifications for PSW's, reviewed work routines, reviewed resident health care records inclusive of care plans, assessments and Power of Attorney documents and observed resident care and services.
