The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 1 to 3, 2018

There following six critical incidents were reviewed concurrently during this inspection:

**-Log #004963-18, #007800-18, #009221-18, #015101-18, #005879-18 and #006155-18.
All of the critical incidents were related to resident to resident physical abuse.**

A complaint inspection (Log # 016387-18) was also completed concurrently during this inspection and was related to the six critical incidents. All areas of non-compliance identified related to the critical incidents, were identified in the complaint inspection report, under inspection # 2018_643111_0014.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), Registered Practical Nurses (RPN), Personal Support Workers (PSW) and Behavioural Support Ontario Staff (BSO).
