The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): April 1-5, 2019.

The following intakes were inspected during this Complaint Inspection:

- One log related to a complaint of improper transfer and positioning techniques of a resident resulting in an injury; and**
- One log related to a complaint of lack of staffing.**

Follow-up inspection #2019_782736_00004 and Critical Incident inspection #2019_782736_00006 were conducted concurrently with this Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Senior Administrator, Director of Care (DOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), residents and family members.

During the course of the inspection, the Inspector(s) also conducted a daily tour of the resident care areas, observed staff to resident interactions and provisions of care, and, reviewed relevant resident health care records.
