Findings/Faits saillants :

1. On a specified date the home submitted a Critical Incident Report to the Ministry of Health and Long Term Care. This report indicated immediate actions to prevent recurrence as internal investigation is in the process. The results of the abuse or neglect investigation were not reported to the Director.

The licensee has failed to comply with ON/Regulation 79/10 section 23.(2).
