The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s. 44(7)(a)(b)

The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,

- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements;
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements;

### Findings:

- 1. The home forwarded letters to the Ministry of Health, the local Community Care Access Centre and each of the applicants, notifying them of a refusal of admission to Extendicare Hamilton. The letters issued to specified applicants did not provide and support valid grounds for refusal.
- 2. Current residents of the home were observed exiting the main entrance for the designated smoking area of the home. The home appears to be meeting the needs of some residents who smoke.
- 3. Discussion held with the Administrator and Director of Care, related to refusal letters submitted confirmed that the specified residents were denied admission for reasons other than a lack of physical facilities or nursing expertise.

**WN #2:** The Licensee has failed to comply with *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s. 44(9)(b)(c).

If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,

- (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care;
- (c) an explanation of how the supporting facts justify the decision to withhold approval;

### Findings:

- According to a letter produced by the home, a specified applicant was refused acceptance "due to current case mix and complexity of our current care requirements". This statement does not provide detailed explanation of the supporting facts, or justification of the decision to withhold approval for this specific individual.
- 2. A specified applicant was refused acceptance. The refusal letter does not clearly explain why the home would not be able to manage the applicant's care given that training was offered to the home from the Community Care Access Centre.
