The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 2, 2016

During the course of the inspection, the inspector(s) spoke with the Administrator, Environmental Services Supervisor and housekeeping staff regarding their pest control program and their cleaning schedules. The inspector spoke to residents regarding any pest sightings.

During the course of the inspection, the inspector toured the 2nd floor home areas including common areas, resident rooms, resident ensuite washrooms and dining rooms, reviewed housekeeping schedules for bedroom cleaning, housekeeping policies and procedures and pest control service reports.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 87. Housekeeping Specifically failed to comply with the following:

- s. 87. (2) As part of the organized program of housekeeping under clause 15 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for,
- (a) cleaning of the home, including,
- (i) resident bedrooms, including floors, carpets, furnishings, privacy curtains, contact surfaces and wall surfaces, and
- (ii) common areas and staff areas, including floors, carpets, furnishings, contact surfaces and wall surfaces; O. Reg. 79/10, s. 87 (2).

## Findings/Faits saillants:

1. As part of the organized program of housekeeping under clause 15(1)(a) of the Act, the licensee did not ensure that procedures were implemented for cleaning of resident bedrooms including floors.

The licensee's procedure titled "Additional cleaning routines" required that resident bedrooms be deep cleaned once per month to ensure areas behind beds and areas around furnishings were thoroughly cleaned and procedure titled "Floor spray buffing cleaning procedure" required that floors be cleaned (using a floor machine) to remove scuffs, marks and ground in dirt once per month.

During the inspection, a tour was completed of many resident bedrooms including #2114, #2117, #2118, #2130, #2131, #2132, #2135, #2140, #2141, #2207, #2214, and #2312. An accumulation of dust was observed behind the head of the beds along the baseboards, behind night tables and around wardrobes. The flooring material in the identified rooms was observed to be dirty in appearance with ground in dirt, traffic patterns, scuffs and stuck on debris. According to the licensee's housekeeping records, the floors for the identified rooms were last deep cleaned between July 13 and September 2, 2015. For three of the identified rooms, no date could be provided. The rooms were last deep cleaned between December 8, 2015 and January 14, 2016. The day to day cleaning routine as detailed under the procedure titled "Dust, damp and wet mopping cleaning procedure", required housekeeping staff to use a dust or wet mop under beds and around furniture to remove accumulated dust but did not appear to be complied with. Based on the observations and records, the licensee's procedures were not implemented for the identified rooms. [s. 87(2)(a)]
