The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 11 and 12, 2021.

The following intake was inspected upon during this Follow Up inspection:

-One log, which was related to compliance order #001 from inspection report #2021_824736_0003, where the home was ordered to comply with section 229 subsection 4 of the Ontario Regulations 79/10, related to the licensee ensuring that all staff participate in the implementation of the Infection Prevention and Control (IPAC) program, specifically, the appropriate usage of Personal Protective Equipment (PPE) and Hand Hygiene, with a compliance due date of February 5, 2021.

A Complaint Inspection #2021_853692_0001 was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Acting Administrator/Director of Care (DOC), Long-Term Care Consultant for Extendicare, Director of Clinical Services for Timmins and District Hospital, Social Worker (SW), Lead Housekeeper, Housekeepers, Dietary Aide, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Support Service Attendants (SSAs), and residents.

The Inspector also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, observed Infection Prevention and Control (IPAC) practices, reviewed relevant health care records, audits, as well as licensee policies, procedures and programs.
