The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 19, 20, 21, 24, 25 and 26, 2016.

The purpose of this inspection was related to Log # 019827-16 CO #001 regarding staff education and training in relation to Zero Tolerance of Abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Assistant Director of Care (ADOC) / RAI Coordinator, Support Services Manager (SSM), Dietary Services Manager (DSM), Resident Program Manager (RPM), Social Worker (SW), Registered Physiotherapist, Registered Nurses (RN), Registered Practical Nurses (RPN's), Food Service Workers (FSW), Maintenance Worker, Housekeeping Staff, Physiotherapy Assistant (PTA), Activity Aides, Personal Support Workers (PSW) and home's voluntaries.

During the course of the inspection, the inspector reviewed the home's policy related to Prevention of Abuse and Neglect, reviewed Staff Training materials and attendance record related to Resident Rights, Prevention of Abuse and Neglect, Mandatory and Critical Incident Reporting. In addition the inspector observed the provision of care and services to residents, observed staff to resident interactions and observed resident to resident interactions.
