The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector reviewed resident health care records, observed resident meal service, staff to resident interaction, infection prevention and control practices, staff providing care to resident, observed the home's supply of resident personal care items and the documentation on the charges for accommodation

During the course of the inspection, the inspector(s) spoke with the resident, family member, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Service Manager, Housekeeper, Registered Dietitian and Food Services Supervisor.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,

(a) the planned care for the resident; 2007, c. 8, s. 6 (1).

(b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).

(c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that the written plan of care for resident #001 sets out clear directions to staff and others who provide direct care to the resident #001.

Resident #001 was admitted to the home with multiple diagnoses and requires extensive assistance with activities of daily living.

During an interview with the inspector #548 the resident indicated that fruit juice was provided for breakfast that day. The inspector observed an empty glass with orange substance at the bottom, on the meal tray in the resident's room.

Review of the Digital Prescriber's Orders form, it is recorded by the Registered Dietitian (RD) that the resident is not to have any fruit juice.

The resident's care plan specified- No fruit juice.

On March 9, 2017 during an interview with the inspector #548 the Registered Dietitian (RD) indicated that the resident was not to have any fruit juice due to the medical management. The RD indicated that the Personal Support Workers (PSWs) prepare meal trays and beverages for each resident with the use of a beverage list that is available to all staff in the dining room. The inspector reviewed the list called Beverage cart list and noted that each resident's fluid requirements are specified. The Beverage list specified that staff are to discourage fruit juices for resident #001. During further interview, the RD indicated that she was not certain why the list did not specify- no fruit juices.

On March 8 and 9, 2017 during an interview PSW #100 indicated that she had prepared the resident's breakfast tray and provided fruit juice on two occasions for breakfast meal service. She further indicated that she was not aware that the resident was not to have any fruit juices. [s. 6. (1) (c)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the written plan of care sets out clear directions to staff and others who provide direct care to the resident #001, to be implemented voluntarily.
