The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 27, 30, 31 and August 1, 2018.

This inspection included six critical incident reports (CIR): three related to alleged resident to resident sexual abuse; two, related to an identified missing resident for more than three hours; and one related to an identified missing resident for more than three hours.

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care, Assistant Director of Care, an attending Physician, Registered Nurses, Registered Practical Nurses, Personal Support Workers and residents.

In addition the Inspector reviewed the health care records of the identified residents, observed resident-resident interactions and the resident's care environment and reviewed documents related to the licensee's investigation into the identified incidents.
