Specifically failed to comply with the following:

s. 6. (4) The licensee shall ensure that the staff and others involved in the different aspects of care of the resident collaborate with each other,

(a) in the assessment of the resident so that their assessments are integrated and are consistent with and complement each other; and 2007, c. 8, s. 6 (4).

(b) in the development and implementation of the plan of care so that the different aspects of care are integrated and are consistent with and complement each other. 2007, c. 8, s. 6 (4).

Findings/Faits saillants:

1. The licensee has failed to ensure that staff and others involved in the different aspects of a resident's care collaborated with each other in the assessment of the resident so that their assessments were integrated, consistent with and complemented each other.

A resident vomited coffee ground emesis on two consecutive nights. The resident refused to go to hospital to be assessed and the resident's substitute decision maker was aware of this and deferred to the resident's choice. The physician on call was informed that the resident had vomited, but was not informed that the resident experienced coffee ground emesis, which is a sign of bleeding in the upper digestive tract. The physician indicated that if they had been aware of the coffee ground emesis they might have contacted the resident's family to inform them of the possibility of bleeding.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff and others involved in the different aspects of a resident's care collaborate with each other in the assessment of the resident so that their assessments are integrated, consistent with and complement each other, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 131. Administration of drugs

Specifically failed to comply with the following:

s. 131. (2) The licensee shall ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber. O. Reg. 79/10, s. 131 (2).

Findings/Faits saillants:

1. The licensee failed to ensure that drugs were administered to a resident in accordance with the directions for use specified by the prescriber.

An RN administered a drug to a resident as per the Laurier Manor Medical Directives (LMMD), which were approved and signed by the resident's physician. At the time the drug was administered the resident had two symptoms which the LMMD indicated were contraindications for use of the drug. As such, the prescriber's directions for use were not followed.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber, to be implemented voluntarily.
