Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 23 to 26, 2021 and March 29 and 30, 2021.

The following logs were completed in this Complaint inspection:

Log #002413-21 related to alleged abuse and resident charges;

Log #001671-21 related to falls prevention, dining, and infection prevention and control (IPAC).

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the IPAC lead, the Dietary Manager, Registered Practical Nurses (RPN), Personal Support Workers (PSW), the Office Manager, a housekeeper, and an Administrative Assistant.

In addition, the inspector(s) reviewed relevant health care records and documents; and observed the provision of care and services to residents, resident care areas, meal service, and infection prevention and control measures.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning
Specifically failed to comply with the following:**

**s. 71. (1) Every licensee of a long-term care home shall ensure that the home's menu cycle,
(c) includes alternative choices of entrees, vegetables and desserts at lunch and dinner; O. Reg. 79/10, s. 71 (1).**

Findings/Faits saillants :

1. The licensee has failed to ensure that the menu cycle included an alternate choice of entrée and vegetable at lunch and dinner.

A complaint was made to the Director that meal choices were not being provided. The Dietary Manager confirmed that for most of 2020, up until two weeks ago, the menu cycle contained one choice of meal and if the resident did not like the meal choice, they would be provided a sandwich.

Inspector reviewed a planned weekly menu from that time period. The menu did not contain an alternate entrée or vegetable at lunch or dinner.
