The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 13th and 14th, 2014

During the course of the inspection, the inspector(s) spoke with Resident # 1 and Resident # 2, several Personal Support Workers (PSWs), two Registered Practical Nurses (RPNs), a Registered Nurse (RN) , the Physio Therapist, the Assistant Director of Care, the Environmental Manager, and the Administrator.

During the course of the inspection, the inspector(s) observed care being provided to Resident #1 and Resident #2, reviewed the two resident's health care records, the homes Fall Prevention and Management Program Policy # RESI-10-02-01 version April 2013, the Post Fall Assessment Policy # RESI-10-02-02 version April 2013, the Falls and Restraint Reduction Meeting minutes of February 26th, 2014, the night RN Security Rounds Check List dated February 25, 2014, the maintenance contract for the home's elevators, the home's Daily Staffing Sheet for March 15, 2014 and the nursing staffing schedule between November 1, 2013 to March 2, 2014
