**Inspection Summary/Sommaire d'inspection**

The purpose of this inspection was to conduct a complaint inspection related to unlawful conduct.

During the course of the inspection, the inspector spoke with 4 registered staff, home's dietitian, and DOC.

During the course of the inspection, the inspector interviewed 4 registered staff as to protocol when resident care requires change to orders for medications especially for analgesics and for changes to wound care treatments. Interviewed the dietitian as to acceptable decisions made by nurses concerning giving resident's a diet different than they are ordered. Reviewed applicable policies and procedures. Reviewed the MD communication books used by staff to indicate changes in resident needs.

There are no findings of Non-Compliance as a result of this inspection.
