The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 24, 25, 2018

The two logs were related to six Critical Incident Reports regarding past outbreaks of acute respiratory illness.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Assistant Director of Care, the Clinical Coordinator and two Registered Nurses.

The Inspector reviewed documentation related to the reported outbreaks of acute respiratory illness (ARI) and to the home's infection prevention and control program. The Inspector observed the carts which contained personal protective equipment for the staff's use, outside of identified residents' bedrooms, on two identified care units.
