**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. Resident #2's plan of care for transferring (Oct 15, 2013) stated that he/she required the use of a mechanical lift.

On Oct 23, 2013, resident #2 was transferred manually by one staff member during the provision of care, as was confirmed by the Director of Care's investigation. As such the licensee did not ensure that the care set out in the plan of care was provided to the resident as specified in the plan. [s. 6. (7)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the care set out in the plan of care related
transferring is provided as specified in the plan, to be implemented voluntarily.***
