During the course of the inspection, the inspector(s) spoke with the Administrator, the Support Services Manager, laundry staff and registered nursing staff on the 2nd floor.

During the course of the inspection, the inspector(s) observed the laundry room, with a focus on the accumulation of soiled personal clothing; reviewed laundry policy #HKLD-06-03-08 titled "Supply Management - Personals"; reviewed a component of the home's Admission package, related to Laundry Services; reviewed minutes from Resident Council meetings held in January, February, March and April 2014; and reviewed the Resident/Family Council update dated January 2014.
