Specifically failed to comply with the following:

- s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:
- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, ss. 24 (1), 195 (2).
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, ss. 24 (1), 195 (2).
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, ss. 24 (1), 195 (2).
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, ss. 24 (1), 195 (2).
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, ss. 24 (1), 195 (2).

Findings/Faits saillants:

1. The licensee failed to ensure that a person who has reasonable grounds to suspect that abuse of a resident by anyone that may result in harm or a risk of harm should immediately report the suspicion upon which it is based to the Director. [s. 24. (1)]

Resident #001 reported to an identified Registered Practical Nurse (RPN) that he/she was abused by a person who came to the home. The RPN reported the allegation to an identified Registered Nurse (RN). An interview with the RN confirmed that the incident was not further reported. Resident #001 reported the incident of abuse to another Registered Nurse who then reported the information to the Assistant Director of Care and then to the Director. [s. 24. (1)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that a person who has reasonable grounds to suspect that abuse of a resident by anyone that may result in harm or a risk of harm should immediately report the suspicion upon which it is based to the director, to be implemented voluntarily.
