The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 91. Every licensee of a long-term care home shall ensure that all hazardous substances at the home are labelled properly and are kept inaccessible to residents at all times. O. Reg. 79/10, s. 91.**

**Findings/Faits sayants :**

1. While conducting a tour of the home, a spa room door, on Walkerville House area, was observed not to be securely closed and no staff was in attendance. Disinfectant chemicals were stored inside, in an unlocked cupboard, allowing resident accessibility.
