Non-compliance with requirements under the Long-Term Care—Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants:

1. One resident sustained an injury from a fall. Review of the resident health record revealed that registered staff post fall assessments were not provided according to the home policy. Interview with the Administrator, Acting Director of Care and one RPN confirmed the assessments were provided to the resident in the manner outlined in the home policy. [LTCHA,2007,S.O.c.8,s.6(7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance related to the care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.
