Specifically failed to comply with the following:

s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,
(a) the planned care for the resident; 2007, c. 8, s. 6 (1).
(b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).
(c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

Findings/Faits saillants :

1. The licensee of the home did not ensure that there is a written plan of care for one resident that sets out clear directions to staff and others who provide direct care to the resident. One resident ingested an unknown amount of chemical substance. The written plan of care does not include directions to staff & others who provide direct care, to monitor the resident's behaviour's for ingestion of foreign objects/liquids. [s. 6. (1) (c)]

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 91. Every licensee of a long-term care home shall ensure that all hazardous substances at the home are labelled properly and are kept inaccessible to residents at all times. O. Reg. 79/10, s. 91.

Findings/Faits saillants :

1. The licensee did not ensure that all hazardous substances at the home are kept inaccessible to residents at all times. One resident had access to and ingested an unknown amount of chemical substance that resulted in health concerns. [s. 91.]
