The purpose of this inspection was to conduct a complaint inspection related to constipation for Resident #1000002.		
The inspection was conducted by the two (2) inspectors identified above.		
The inspection occurred on August 5, 2010.		
During the course of the inspection, the inspectors spoke with members of the management team, including the Administrator, Director of Care, RAI Coordinator, Clinical Coordinator, Nutrition Manager; resident #1000002, and registered nursing staff who work in St. Clair resident home area. A review of resident #1000002's records was completed. On Aug.5, 2010, resident was observed eating their lunch in the St. Clair dining room.

WN#1: The Licensee has failed to comply with: LTCHA, 2007, S.O 2007. c. 8, s. 6 (1). Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out, clear directions to staff and others who provide direct care to the resident.

Findings:

1. Resident's plan of care in effect until Sept. 22, 2010 does not identify constipation as a problem; nor does the plan of care provide interventions or directions to staff providing direct care to this resident with a diagnosis of constipation.

Further Inspector Actions:

VPC –pursuant to LTCHA 2007, S.O 2007, c. 8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to be implemented voluntarily.

WN#2: The Licensee has failed to comply with: LTCHA, 2007, S.O 2007, c. 8, s 6(10)(b) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when, the resident's care needs change or care set out in the plan is no longer necessary.

Findings:

1. Resident returned from hospital Nov. 21/09 with diagnosis of constipation. Resident's quarterly MDS assessment Dec. 8, 2009 did not identify constipation as a problem. Resident's most recent full MDS assessment June 8, 2010 did not identify constipation as problem. According to staff the resident has a known history of constipation for the last 8 months that have not been assessed or reassessed to meet resident's changing needs. Interventions been not been developed as part of the resident's plan of care. Resident was admitted to hospital Aug. 3/10 with a diagnosis of constipation.

VPC –pursuant to LTCHA 2007, S.O 2007, c.8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to be implemented voluntarily.

Findings:

- 1. No other interventions were put in place except medication for constipation since Nov. 2009. There have been no revisions to the resident's plan of care related to constipation since Nov. 2009.
- 2. Resident has not been reassessed for constipation since Nov. 2009.

VPC –pursuant to LTCHA 2007, S.O 2007, c.8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to be implemented voluntarily.

The licensee shall ensure that the staff and others involved in the different aspects of care of the resident collaborate with each other, in the assessment of the resident so that their assessments are integrated and are consistent with and complement each other.

Findings:

1. Nursing staff interviewed indicated that there was a known problem of constipation with resident since Nov.

The resident's constipation has not been addressed in the Resident's nutritional plan of care or the MDS assessments of Dec. 8, 2009 and June 8, 2010.

#### Findings:

1. Resident was diagnosed with constipation in Nov. 2009. Nursing staff interviewed stated constipation was a known problem. Constipation was not identified on the plan of care, nor was a referral made to the home's Dietitian.

Further Inspector Actions:

VPC -pursuant to LTCHA 2007, S.O 2007, c.8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to be implemented voluntarily.

The licensee shall ensure that a registered Dietitian who is a member of the staff of the home, completes a nutritional assessment for all residents on admission and whenever there is a significant change in a resident's health condition.

#### Findings:

1. Resident was not referred or reassessed by home's Dietitian upon resident's return from hospital after significant change in health status related to constipation in Nov. 2009.

Where the Act or this regulation requires the licensee of a long-term care home to have, instituted or otherwise put in place any procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system is in compliance with and implemented in accordance with all applicable requirements under the Act.

### Findings:

1. Resident had diagnosis of constipation since Nov.21/09. Since that time the home has not provided resident with nutrition related high fibre protocols as per the home's nutritional bowel interventions policy to assist the resident with constipation.

VPC –pursuant to LTCHA 2007, S.O 2007, c.8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to be implemented voluntarily.

The licensee shall ensure that an individualized menu is developed for each resident whose needs cannot be met through the home's menu cycle.

1. Resident had a history of constipation since Nov.2009. There are no high fibre protocols in place for this resident as part of their nutritional plan of care.
