Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 13-16 and 19-21, 2020.

The following intakes were inspected during this Follow up Inspection:

One Follow up related to compliance order #001 under s. 23. (1) of the LTCHA issued during inspection #2020_822613_0011 related to ensuring that every alleged, suspected or witnessed incident of abuse or neglect of a resident by anyone was immediately investigated and appropriate action was taken in

response to every such incident;

One Follow up related to compliance order #002 under s. 24. (1) of the LTCHA issued during inspection #2020_822613_0011 related to ensuring that a person who had reasonable grounds to suspect that abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or risk of harm to the resident immediately reported the suspicion and the information upon which it was based to the Director;

One Follow up related to compliance order #003 under s. 20. (1) of the LTCHA issued during inspection #2020_822613_0011 related to ensuring that the licensee's written policy to promote zero tolerance of abuse and neglect of residents was complied with by all staff.

A concurrent Complaint Inspection #2020_822613_0020 and Critical Incident Inspection #2020_822613_0021 was conducted during this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator (ADM), Director of Care (DOC), Assistant Director of Care (ADOC), Registered Nurses (RNs), Registered Practical Nurses(RPNS), Personal Support Workers (PSWs), Housekeeping staff and residents.

The Inspector also conducted daily tours of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, reviewed health care records, internal investigation files, staff training records, audits and reviewed the licensee's compliance action plan and Zero Tolerance of Resident Abuse and Neglect program.
