s. 23. (2) A licensee shall report to the Director the results of every investigation undertaken under clause (1) (a), and every action taken under clause (1) (b). 2007, c. 8, s. 23 (2).

Findings/Faits sayants :

1. The licensee failed to report the results of the Mandatory Report investigation to the Director. On July 6, 2011 the inspector interviewed the DOC/Acting Administrator. The inspector asked her if the licensee ensured that the results of this Mandatory Report investigation were reported to the director. She reported, "No, we have not reported the results of the investigation".
