Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 15-19, 2021.

The following intakes were inspected during this Inspection:

One Follow Up intake related to compliance order #001 under s.19 (1) of the LTCHA issued during inspection #2021_822613_0017 related to ensuring all residents were protected from abuse;

One Follow Up intake related to compliance order #002 under s. 20. (1) of the LTCHA issued during inspection #2021_822613_0017 related to ensuring that there was in place a written policy to promote zero tolerance of abuse and neglect of residents, and that the policy was complied with;

One Follow Up intake related to compliance order #003 under s. 6. (7) of the LTCHA issued during inspection #2021_822613_0017 related to ensuring that the care set out in the plan of care was provided to the residents as specified in their plan; and

One Follow Up intake related to compliance order #004 under of the s. 24. (6) of the LTCHA issued during inspection #2021_822613_0017 related to ensuring that the care set out in the 24-hour care plan was provided to the residents as specified in their plan.

A Complaint Inspection #2021_822613_0027 and a Critical Incident System Inspection #2021_822613_0028 were conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Assistant Director of Care (ADOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and residents.

The Inspector(s) also conducted daily tours of resident care areas, observed the provision of care and services to residents, infection prevention and control (IPAC) practices, staff to resident interactions, reviewed health care records, and various licensee's policies, procedures and programs.
