The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 13, 14, 15 and 16, 2016.

The purpose of this inspection was related to Log # 032317-16, 032832-16, and 033206-16 regarding resident to resident alleged abuse. The following critical incident Log #026029-16 was inspected related to an incident that causes an injury to a resident for which resident was transferred to hospital.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW) and a resident family member.

During the course of the inspection, the inspector reviewed Critical Incident (CI) reports, reviewed residents health record (including care plans, progress notes, assessments, medication administration records, Geriatric Psychiatry Outreach reports, PSW daily care documentation and Fall incident reports), and home's internal investigation documentation, as applicable.

In addition the inspector observed the provision of care and services to residents, observed staff to resident interactions and observed resident to resident interactions.
