The licensee has failed to ensure that where the licensee withholds approval for admission, the licensee shall give to the applicant, the Director, and the appropriate placement coordinator, a written notice setting out a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; and an explanation of how the supporting facts justify the decision to withhold approval.

A refusal letter for applicant #001 from Extendicare West End Villa was submitted to the Director by Placement Coordinator #101 on a specified date.

In an interview with DOC #100, they told Inspector #732 that they could not approve applicant #001's admission as they did not have a physician within the home able to prescribe a specified medication and assume responsibility for applicant #001's management in regards to that medication.

Inspector #732 reviewed the refusal letter for applicant #001. The letter sets out the grounds for which the applicant was refused, indicating that the home lacks nursing and medical expertise to be able to administer the specified medication; but does not give a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care, as well as no explanation of how the supporting facts justify the decision to withhold approval.

In conclusion, the licensee has failed to ensure that a written notice containing all required details was given to the applicant, the Director, and the placement coordinator. [s. 44. (9)]
