The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning  
Specifically failed to comply with the following:**

**s. 71. (1) Every licensee of a long-term care home shall ensure that the home's menu cycle,  
(c) includes alternative choices of entrees, vegetables and desserts at lunch and dinner; O. Reg. 79/10, s. 71 (1).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that the menu cycle included alternate choices of entrees and vegetables.

On March 18, 2019 at dinner, residents on the third (3rd) floor were offered ham, mashed potatoes and a vegetable pick of the day. The alternates of cod, scalloped potatoes and peas were not offered.

On March 19, 2019 at lunch and dinner, residents on the 3rd and fifth (5th) floors were not offered alternate choices of entrees and vegetables.

From March 20 to 27, 2019, at lunch and dinner, residents on the 3rd, fourth (4th) and 5th floors were not offered alternate choices of entrees and vegetables.

According to the Administrator, the decision was made to offer a limited menu due to an enteric outbreak in the home.

entrees and vegetables, to be implemented voluntarily.***
