The purpose of this inspection was to conduct a Critical Incident inspection.

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care, Assistant Director of Care, several Registered Nurses (RN), several Registered Practical Nurses (RPN) and to several Personal Support Workers (PSW).

During the course of the inspection, the inspector(s) reviewed the health care records for an identified resident and for an identified former resident; observed resident care and services; examined commode shower chairs and reviewed the home's "Tub/Shower Chair" educational inservice notes as well as the home's "Lock Out and Tag Out Broken Equipment" educational inservice notes.

It is noted that during this inspection, two critical incident inspections log # O-000535-11 and #O-000581-11, were completed.
