The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the home's Administrator, the Director of Care, the Assistant Director of Care, the Dietary Manager, the Medical Pharmacy Quality Assurance representative, several Registered Nurses (RN), several Registered Practical Nurses (RPN), several Personal Support Workers (PSW) as well as several residents.

During the course of the inspection, the inspector(s) reviewed the health care records for three identified residents; reviewed the health care records for an identified former resident; observed resident care and services, looked at resident call bell system; reviewed pharmaceutical, housekeeping and maintenance services.
